- 1.2. The document sets out the rules for the Industry Sessions Programme fees, fee refunds are under the Refund and Compensation Policy for students and direct learners studying The Creative Industries Masterclass programme through THE HOUSE OF RADHA online and in-person Industry Sessions.
- 1.3. THE HOUSE OF RADHA charges different fees depending on a number of factors including; your industry programme sessions, which country you study in, and the session mode, online or in-person.

DEFINITIONS IN THIS FEE POLICY DOCUMENT AND THEIR MEANINGS:

CURRENT STUDY YEAR 2024	For the purpose of this policy document, this means the current year the Student or Direct Learner is registered. Our Industry Sessions are All year round and don't have specific start and finish dates.
INITIAL REGISTRATION FEE	Means the fee you are required to pay to at the beginning of the registration process with us to study the online or in-person sessions.
APPLICATION FEE	Means the non-refundable fee for your application to be considered by us. This is charged to all Students and Direct learner applications.
INDUSTRY SESSION FEE	All our programme sessions are based on a pay as you go system. You register for each Industry session and pay once you are confirmed a place. This happens for each industry session whether it is for an online or in-person that includes an assessment and feedback from the Industry Master teaching
REGISTRATION	Means the online registration with us as notified to you in the offer.

INDUSTRY SESSION PROGRAMME FEES	Means fees payable to THE HOUSE OF RADHA which includes, where applicable, registration fees, programme industry session fees, remote industry internship placement fees all published in the Fee Schedule document.
FEE SCHEDULE 2024	Means this document.
INDUSTRY STUDY SESSION	Means a defined period of time allocated for the study of a specified Industry project or Session.
WEB SUPPORTED	Industry Session where students and direct learners are supported and assisted online by our Industry Masters and Employability and Careers team.

3. FEES REVIEWS

- 3.1. Fees will be reviewed annually and will be published on the Programme fee webpage and digital marketing material.
- 3.2. The Creative Industries Masterclass Programme online and in-person programme sessions are offered all year round and allow students and direct learners to study flexibly over an extended period that suits their development needs. Therefore, it may be necessary from time to time in making changes to the fees, rules and policies during the period of registration.
- 3.3. Online Fees and In-person Industry session fees are varied. This is because of the in-person sessions due to the session location and setup costs.

4. ADDITIONAL COSTS

- 4.1. The published fees do not include costs for travel to in-person sessions in the UK or Internationally.
- 4.2. While we endeavour to provide learning factsheets and reading lists that support the industry session through the programme, some programmes may require you to purchase certain software or textbooks that will support your learning in the session or recommended for person and professional development.

- 4.3. All fees shown are net of any local Value Added Tax (VAT), Goods and Services Tax (GST) or any other sales tax payable by the student or direct learner in their country of residence.

Where THE HOUSE OF RADHA is required to add GST or any other sales tax or statutory charges at the local statutory rate, this will be added to the fees shown during the payment process. For students and direct learners who are resident in the UK our fees are exempt from VAT.

- 4.4. The Industry Sessions that will be taught in-person through an Educational Institution or Private Sector learning provider will also have added expenses for travel and accommodation, if the Industry Master is teaching in-person in the UK or in an International country.

5. FEES AND WHAT TO PAY

- 5.1. The following fees may be charged on all Programme Industry Sessions, where applicable, as indicated in the table. For details of when you may be eligible for a refund, see the (Refund and Compensation Policy).
- 5.2. You must pay an Application fee when registering for the Industry session, which is part of the registration process and then the team, will start assessing your application.
- 5.3. The only time we will close the admission to the Industry sessions is when we are fully booked, and unable to take any bookings for the calendar month. If this is the case we will let you know the next available session date registration.

- 5.5. Applicable resource material will not be shared through email with you until the registration process is completed, and fees are paid in full.
- 5.6. UK Residents will have different fees from International students for the in-person sessions, whereas the online sessions will remain the same worldwide through the direct learning platform for 2024.
- 5.7. Your payment provider may apply additional transaction fees, including in respect of any refunds. (If in doubt, please check with them before making a payment).
