#### 3. FEES REVIEWS

- 3.1. Fees will be reviewed annually and will be published on the Programme fee webpage and digital marketing material.
- 3.2. The Creative Industries Masterclass Programme Remote Industry Internship Placements are offered all year round and allow students and direct learners to gain experience flexibly over an extended period that suits their development needs. Therefore, it may be necessary from time to time in making changes to the fees, rules and policies during the period of registration.
- 3.3. All fees shown are net of any local Value Added Tax (VAT), Goods and Services Tax (GST) or any other sales tax payable by the student or direct learner in their country of residence.
- 3.4. Where THE HOUSE OF RADHA is required to add GST or any other sales tax or statutory charges at the local statutory charges at the local statutory rate, this will be added to the fees shown during the payment process. For students and direct learners who are resident in the UK our fees are exempt from VAT.

#### 4. FEES AND WHAT TO PAY

- 4.1. The following fees will be charged on all Remote Industry Internship Placements, where applicable, as indicated in the table. For details of when you may be eligible for a refund, see the (Refund and Compensation Policy).
- 4.2. You must pay an Application fee when registering, which is part of the registration process and then the team, will start assessing your application.
- 4.3. The only time we will close the admission to the Remote Industry Internship Placements is when we are fully booked, and unable to take any bookings for the calendar month. If this is the case we will let you know the next available session date registration.

- 4.5. Applicable resource material will not be shared through email with you until the registration process is completed, and fees are paid in full.
- 4.6. Your payment provider may apply additional transaction fees, including in respect of any refunds. (If in doubt, please check with them before making a payment).

#### 5. THE HOUSE OF RADHA REMOTE INDUSTRY INTERNSHIP PLACEMENT ROLES

The Remote Industry Internship placement roles cover Creative and Business Job roles through THE HOUSE OF RADHA so that you get real-world experience and insight working within a company. The experience will provide you with an understanding of the standards and practices used in the Creative Industries. Learning and developing new industry practices, employability skills and techniques that will support your career aspirations and educational programme.

#### 6. OUR REMOTE INDUSTRY INTERNSHIP PLACEMENTS RUN THROUGHOUT THE YEAR

Our year-round start dates will provide a flexible opportunity, so you can choose the start date for your Remote Internship Industry Placement that aligns with your availability and commitments. We offer various duration options through the packages, and if you want to work full-time or part-time to complete your internship. The team will work with you to accommodate your needs and if you have any extra support requirements.

Through the experience, you may work as part of a team and collaborate on tasks and projects. Or directly with your line manager and on your initiative to help you develop those employability and transferable skills at the Industry level.

#### 7. BENEFITS OF THE REMOTE INDUSTRY INTERNSHIP PLACEMENT EXPERIENCE

Choose from 19 Remote Industry Internship Placement Roles to work within THE HOUSE OF RADHA that will provide you with essential experience and develop employability and transferable skills, knowledge and understanding of the area that you would like to work in. The experience will support your resume and portfolio as you work on real-time projects and tasks through the internship. You must be 18+ when applying for any of our Industry roles, as this is part of the criteria to access the remote Industry Internship placements.

#### 8. ACADEMIC CREDIT FACILITATION WITH EDUCATIONAL INSTITUTION

Our team will be able to liaise with your Educational institution to help arrange learning credits (if applicable), that will support your programme once you confirm your place and complete the Remote Industry Internship Placement process.

#### 9. PERSONAL DEVELOPMENT PLAN SESSIONS

We support your personal and professional development through sessions as part of the Remote Industry Internship Placement. You will log your learning and development each week and use this as reflection time and discuss any questions or development with your line manager throughout. The Personal Development Plan supports your goals and learning needs for the future and your resume and portfolio as part of the experience.

#### 10. CERTIFICATE OF ACHIEVEMENT

Once you have completed your Remote Industry Internship Placement, you will presented with a Digital Certificate of Achievement. The Certificate will outline your Internship experience and skills gained through the internship and will support your resume and professional portfolio.

#### 11. INDUSTRY REFERENCE LETTER

As part of the Remote Industry Internship placement, you can request a reference of recommendation from your line manager once completing the Internship placement. The reference will support any future job applications or educational programmes you are applying for and require a professional reference. It will include your professional accomplishments, providing feedback whilst working in the team and highlighting your strengths through the internship.

#### 12. COST EFFECTIVE WAY TO GAIN EXPERIENCE

You do not have to worry about travel or arranging accommodation to attend your Remote Industry Internship Placement as you can work anywhere as long as you have access to a laptop/computer and a good internet connection. Our Remote Industry Internship Placements provides flexibility, so it fits easily into a busy lifestyle and when you have home commitments.

#### 17. ENGLISH LANGUAGE, READING AND WRITING REQUIREMENTS

If you are coming through an educational institution, we will want you to have a minimum foundation level of education or equivalent industry experience. Our Remote Industry Internship Placements are in English, so if this is not your first language, we recommend that you have at least 5.5 IELTS or equivalent in Speaking, Reading and Writing or have completed your last two years of school through English.

#### 18. AGE AND EXPERIENCE REQUIREMENTS

If you are coming from an Educational Institution then you will need to be 18+ studying a full-time or part-time programme in the subject area you are applying for as a Remote Industry Internship Placement or have some relevant experience and understanding of it.

#### 19. WORK FROM ANYWHERE

Have the freedom to work from anywhere as long as you have access to a laptop or computer with a good internet connection. It would mean the experience would be smooth when attending meetings with your line manager and working through the remote internship placement. If you want to apply for a creative role, you must have access to computer software such as Adobe CC, Illustrator, Photoshop, Indesign and Microsoft Office.

#### **20. ONLINE INTERVIEW**

During the Remote Industry Internship Process, you will need to attend an online Interview so that we can learn more about your education, career aspirations and development needs. You will then have the opportunity to ask questions about the Internship and company so you feel that it is the right fit for you to support your career and educational programme.
